

# Official Rules: The Ultimate Outdoor Bundle Giveaway

## 1. Sponsor and Eligibility

The 'Ultimate Outdoor Bundle Giveaway' ("Promotion") is administered by Wrkced Productions ("Sponsor"), and is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age as of the date of entry.
