

Official Rules: \$250 Uber Eats Feast Drop Giveaway

1. Sponsor

This Giveaway ("Promotion") is sponsored and administered by Wrkcd Productions ("Sponsor"), with principal offices in the United States.

2. Eligibility

The Promotion is open to all legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at time of entry.

A random drawing will be conducted within seven (7) days following the Promotion Period from all eligible entries received.

The potential winner must respond within seventy-two (72) hours of notification or an alternate winner may be selected.
